Know Your Customer (KYC) - customer communications update

'Know Your Customer' or 'KYC' is a necessary part of our risk mitigation program and a requirement under the Anti-Money Laundering and Counter-Terrorism Financing Act 2006.

As part of our KYC refresh program, we're now starting our outreach to non-individual customers ie, entities such as companies, trusts, partnerships etc.

Initially, we're contacting customers that are government bodies/organisations. These customers must complete a Know Your Customer form and post it to AMP Bank with documents to confirm the entity's details and original acceptable certified identification documents for certain account parties specified in the form. Customers must complete KYC refresh within the specified timeframes, or restrictions may be placed on their account(s).

Since June 2022, we have had a good response to our individual customer outreach, and we will continue to contact non-individual customers in 2023.
