Variable rate change

Effective Friday, 5 May 2023 and Monday, 8 May 2023

We're increasing interest rates for new and existing variable rate home loans, effective 5 May 2023 for new business and 8 May 2023 for existing customers.

The decision follows the Reserve Bank of Australia (RBA) increasing the official cash rate by 25bps on 2 May 2023.

Decisions on rates are never taken lightly and we'll continue to focus on providing competitive rates for both our home loan customers and savers.


